Approval of April Minutes (with one date typo correction) – (Joel moved/Dan seconded)

Liaison Reports – all reports accepted (Laura D. moved/John seconded):

- Property (report from Joel)
  - Sent mowing schedule link to list of people who typically volunteer sign-up schedule is also posted on the bulletin board
  - Door handle for safe room door has been replaced
  - More water coming in to the basement whenever it rains, leaking thru a seam crack in east wall below the windows; John is talking with McDonald plumbing on the 24<sup>th</sup> regarding the basement sump pumps, which should take care of some of the issue.

- Worship & Music (written report from Rev. Mike)
  - Restored some of the pre-pandemic liturgical elements to our worship:
    - Prayers of the People readers from the congregation
    - Passing the offering plate (including Noisy Offering on May 1)
    - Offertory hymn and doxology

Treasurer's Report – (written report from John) accepted (Angela moved/Dan seconded)

- The check for \$70 thousand in Ascension investments has arrived at Vanguard will be put into holding money market account and then can be transferred to other investment accounts.
- First time in quite a while that income for the year-to-date shows as less than expenses. Due in part to paying for the two new furnaces which we did not budget for. EOM April showed \$352 less in income vs. expenses year-to-date, so still doing very well.

Old Business:

- Ascension Hall signage Joel still working on it. Plans to have ready by Ascension.
- Laptop for Hybrid Events / Camera & Mic for Office PC
  - All are in the building now camera/mic is "plug & play" so will work well with office desktop computer or as additional movable camera for laptop
