- Discussed ramifications of potential for ICE Agents to enter our building.
  - Discussed that they are allowed to enter any "public space" but they can not interrupt a worship service.
  - They are not allowed to enter private spaces, such as Polly's office, or Jill & John's office.
     Discussed possibly getting labels that say "Private" for the doors no decisions made.
- Allison McCully from "Together West Michigan" will be here during fellowship time May 4<sup>th</sup> for an event, facilitating discussions around the question "What keeps you up at night?".

  - Lisa (our cleaner) discovered a drip in the sanctuary. John/Joe investigated and discovered that
    the heating tape that had been installed to alleviate the roof icing/leaking issue had been
    unplugged during a roof repair. It has now been plugged back in.
  - Discussed possibly putting in motion detector sensors for the lights in the bathroom. Whole leadership team highly approved this suggestion and requested that it be done.
